## *MINOT STATE UNIVERSITY SCHOLARSHIP*

Any current DECA member of the High School Division who intends to pursue a full-time course of study in a related business, marketing, or management field may apply. The North Dakota DECA Scholarship at Minot State University is merit based and is not based on financial need. However, if an applicant chooses, he or she may include a statement in support of financial need and it will be reviewed.

One \$1,000 scholarship will be awarded. The scholarship is for a student attending Minot State University, Minot, North Dakota during the 2017-2018 school year.

The recipient must commit to be an active member of the College DECA Chapter at MSU.

Applicants must have an ACT SCORE of 23 or higher to apply for this scholarship.

Deadline for application: February 13, 2017.

The following items **MUST** be included with the application:

1. The application form completed in its entirety.
2. An official transcript of high school grades.
3. Scholastic Assessment Test or American College Testing Program score.
4. An essay no more than ONE PAGE on the topic: "How my experience in DECA has clarified my career goals and helped me move toward them."
5. Two (2) letters of recommendation, one from your chapter advisor and one other person (community, school, employment)
